Despite service of notice, neither the appellant nor the respondent has chosen to appear. The Appellate Board has perused the impugned Order. As per Section 8-B of the Press & Registration Books Act,1867, the Magistrate has been given power to cancel the declaration but not the registration.

The Appellate Board is of the opinion that the Sub-Divisional Magistrate while exercising the power under Section 8 B of the Act cannot direct cancellation of registration of the newspaper. In this way he has exercised a power, which is not vested in him. On this ground alone, the impugned order is illegal and cannot be allowed to stand.




