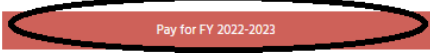

Q.5 Can payment be made through DD/Cash?

- NO DD/Cash shall be accepted. Payment only through Online.

Q.6 While remitting the levy to the Council the publishers often raise query whether the fees remitted by them are meant for the membership of the Council.?

Ans:-Section 16(1) of the Press Council Act, 1978 empowers the Council to levy such fees, at such rates and in such manner, as may be prescribed, from registered newspapers and news agencies and different rates may be prescribed for different newspapers having regard to their circulation and other matters. There is no provision in the Press Council Act, 1978 for individual membership. Only press organizations having all India character, notified by the Council under Section 5(4) of the Act may send panel of names for election as members from the category. The law members are nominated by the organizations specified under Section 5(3)(d) and (e) of the Press Council Act, 1978 i.e. University Grants Commission, Sahitya Academy, Bar Council of India, Lok Sabha and Rajya Sabha.

Q.7 Publisher often raise query as to what benefit/facility would be achieved by them after remitting levy to the Council.?

Ans:-The Press Council of India has been established under the Press Council Act with the avowed object of preserving the freedom of the Press and of maintaining and improving the standards of newspapers and news agencies in India. All the media persons are free to file complaint before the Council for their harassment, curtailment of press freedom namely, advertisements, accreditation cards and other passes etc.

Q.8 While remitting the levy to the Council the publishers often raise query whether the fees remitted by them are meant for the membership of the Council.?

Ans:-Section 16(1) of the Press Council Act, 1978 empowers the Council to levy such fees, at such rates and in such manner, as may be prescribed, from registered newspapers and news agencies and different rates may be prescribed for different newspapers having regard to their circulation and other matters. There is no provision in the Press Council Act, 1978 for individual membership. Only press organizations having all India character, notified by the Council under Section 5(4) of the Act may send panel of names for election as members from the category. The law members are nominated by the organizations specified under Section 5(3)(d) and (e) of the Press Council Act, 1978 i.e. University Grants Commission, Sahitya Academy, Bar Council of India, Lok Sabha and Rajya Sabha.

Q.9:-Who is liable to Pay Levy?

Ans:-All News Papers registered in India having circulation range above 25000 copies per issue pay levy on graded scale as notified from time to time.
